

Suggested Wording for a Gift in Will to Hudson Institute

Hudson Institute of Medical Research's promise to you

We understand that leaving a gift in Will is a significant and personal decision, and we promise to treat any gift you decide to leave us with care, confidentiality, respect and in line with your wishes. Your privacy will always be respected, and we will never pressure you to make a decision about leaving a gift in your Will. Hudson Institute also understands the importance of taking care of your loved ones and that they will always come first.

Specific wording for your Will

We recommend that you seek professional advice from a legal adviser to ensure your wishes are recorded and thus distributed in a legally binding way, in the manner in which you intend and to ensure your family and friends are provided for.

The wording below is suggested as a general guide for you and your advisors. We recommend you seek legal advice when making your Will as individual circumstances may vary.

Suggested bequest wording | *I bequeath to Hudson Institute of Medical Research ABN 48 132 025 024 for its general purposes the residue OR a percentage of my Estate OR a specified sum OR specified item/s free of all duties, and the receipt of an Authorised Officer from Hudson Institute shall be full and sufficient discharge to my executors.*

Suggested wording to leave a Residuary Gift | *I give free of all taxes and testamentary expenses the whole (or percentage share) of the residue of my estate to Hudson Institute of Medical Research (ABN 48 132 025 024) to be used for its general purposes, and the receipt of an authorised officer from Hudson Institute shall be full and sufficient discharge to my executors.*

Suggested wording for a Specific Gift | *I give free of all taxes and testamentary expenses the (describe the specific gift) to Hudson Institute of Medical Research (ABN 48 132 025 024) to be used for its general purposes, and the receipt of an authorised officer from Hudson Institute shall be full and sufficient discharge to my executors.*

Suggested wording for a Pecuniary Gift | *I give free of all taxes and testamentary expenses the sum of \$_____ (in figures and words) to Hudson Institute of Medical Research (ABN 48 132 025 024) to be used for its general purposes, and the receipt of an authorised officer from Hudson Institute of Medical Research shall be full and sufficient discharge to my executors.*
